- the maintenance and restoration of historical and/or cultural structures and monuments; scholarships and bursaries for persons of the Solu-Khumbu region of Nepal who engage in studies or training programs directly connected with and/or to further the objects of the Foundation;
- The implementation of all such things as are incidental or conducive to the attainment of the above objects.

To distribute the funds pursuant to the aforesaid objects provided that such funds shall be distributed by its agents to the people of the Solu-Khumbu Region of Nepal and that the Canadian origin of such aid is made known at the point of distribution.

To accept donations, gifts, legacies and bequests for use in promoting the above objects and carrying on the work of the Foundation; and

To invest undistributed funds of the Foundation in investments authorized by law for the investment of the trust funds.
